fire-Personal wood-cutting permits are on sale

The Modoc National Forest will begin offering special rates on personal firewood cutting permits on May 15, 2023. Permits are available for \$2 per cord with a minimum purchase of \$20 and a limit of ten cords per permit. The term cord refers to the amount of wood tightly stacked in a stack four feet high, four feet wide, and eight feet long.

A fuelwood permit can be obtained from the Modoc Forest Headquarters in Alturas, California with photo identification, with potential options for other District Office sales. Only cash, checks, money orders, and credit/debit cards will be accepted as forms of payment.

It is necessary to obtain a permit and accompanying wood cutting map to remove wood from the forest. You will also need to bring your own saw and fire extinguisher. Vehicles larger than a pickup truck or commercial types of machinery may not be used.

The Modoc National Forest is providing opportunities for fuelwood gathering. This will provide fuelwood to the community while decreasing the fuel-loading in the forest and reducing the chances of catastrophic wildfire.
