AN ORDINANCE OF THE CITY OF ALTURAS ADDING SECTION 6 "RESERVE OFFICER PROGRAM" TO CHAPTER 19 "POLICE"

WHEREAS, the City Council of the City of Alturas does ordain as follows:

Section 1. Section 6 "Reserve Officer Program" of Chapter 19 "Police" is hereby added as follows:

In Summary: Under the authority granted in Article XI, Section 7 of the California Constitution and the California Penal Code, Section 836.2, the City of Alturas, by and through its Council, does enact the Police Reserve Officer Program. This program will allow the Chief of Police to appoint a Reserve Officer to assist the Alturas Police Department when needed. A full copy of the ordinance is available for review at the Alturas City Clerk's Office, Alturas City Hall, 200 North Street, Alturas, CA 96101.

Section 2. This Ordinance shall take effect thirty (30) days from the date of its passage. Before the expiration of fifteen (15) days after its passage, this Ordinance shall be published in the Modoc Record, a newspaper of general circulation, printed and published in the City of Alturas in a manner meeting the requirements of California Government Code Sections 36931 through 36937.

Section 3. This Ordinance shall also repeal any temporary Ordinance in effect establishing a Reserve Officer program after its effective date.
