Employment scams

They will ask you to purchase computers and office equipment with the promise of reimbursement or claim to have overpaid you for your work. Reimbursements and overpayments will be reversed, leaving you responsible for the funds.

Payment scams

Scammers often provide customers with illegitimate bank information, offering to pay off your credit card balance—and possibly asking for gift cards or cash in return. But the payment is frequently reversed, leaving you responsible for the entire credit card balance.

Impersonating Capital One

Scammers will try to pose as Capital One and ask you to provide your personal information or even transfer money by phone, text or email. In this process, the scammer is attempting to gain access to your account.

Social media marketplace scams
