#### TULELAKE MUNICIPAL AIRPORT **PROPOSED PERIMETER FENCE PROJECT** NOTICE OF AVAILABILITY National Historic Preservation Act 30 Day - Opportunity to Provide Views Regarding **Resolution of Adverse Effect**

The County of Modoc (County) proposes the installation of an 8-foot-tall fence around the perimeter (undertaking) of the Tulelake Municipal Airport (Airport) property. The purpose of this undertaking is to deter wildlife and people from uncontrolled entry into the aviation operations area (AOA) thereby enhancing safety at the Airport. Uncontrolled entry to the AOA creates unacceptable risk to the aircraft, pilot, wildlife, and persons in the vicinity of the operations. The County is seeking Federal Aviation Administration (FAA) approval of an Airport Layout Plan and intends to request federal funding in support for the proposed fence installation. The FAA is the lead federal agency to ensure compliance with the National Environmental Policy Act (NEPA), 40 Code of Federal Regulations (CFR) Parts 1500-1508, for proposed airport development actions. The NEPA document will be completed in accordance with FAA Orders 1050.1F, Environmental Impacts: Policies and Procedures, and 5050.4B, NEPA Implementing Instructions for Airport Actions. Pursuant to the National Historic Preservation Act, Section 106 (NHPA) regulations detailed in 36 CFR- Part 800, the FAA is evaluating the proposed undertaking. Based upon extensive coordination and cultural resource evaluation, the FAA, and the California State Historic Preservation Officer (SHPO) have agreed that construction of the proposed fence would result in an *adverse effect* to historic properties/historical resources. ## **American Legion seeks Boys** & Girls State candidates
